OF PROCUREMENT- NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT)
ON THE PROCUREMENT OF DIVISION OFFICE AIR CONDITIONING UNIT CLEANING AND MAINTENANCE
FOR THE YEAR 2023**

WHEREAS, the Department of Education, Division of Ozamiz City Bids and Awards Committee (BAC) recognized the need to procure the Division Office air conditioning unit cleaning and maintenance for the year 2023.



Sumondong, that alternative method of procurement such as Negotiated Procurement (Small Value Procurement) be resorted to in the procurement of Division Office air conditioning unit cleaning and maintenance for the year 2023.




