**A BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD OF PROCUREMENT-
SHOPPING FOR THE PROCUREMENT OF OFFICE SUPPLIES FOR THE 4TH QUARTER OF 2022**

WHEREAS, the Department of Education, Division of Ozamiz City is mandated to implement programs and projects relative to the realization of DepEd Vision and Mission as stipulated in RA 9155;

WHEREAS, the Department of Education, Division of Ozamiz City Bids and Awards Committee (BAC) recognized the need to procure Office Supplies for the 4th Quarter of 2022;

WHEREAS, the needed supplies are not available per Certificate of Non-Availability of Stocks (Online) and not in the List of Common Supplies and Equipment in procurement Service CDO Depot as of October 18, 2022;

WHEREAS, the amount of the items to be procured does NOT exceed the threshold of what is provided for in Annex H of IRR of RA 9184, as it is only *Seventy-One Thousand Nine Hundred Ninety-Nine Pesos and 99/100 only (Php 71,999.99)*;

WHEREAS, on motion of the BAC Member Mae Onyx A. Ybañez and duly seconded by BAC Member Michael B. Bartolaba, that alternative method of procurement such as Shopping be resorted to in the procurement of Office Supplies for the 4th Quarter of 2022;

NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the BAC resolution recommending the use of Shopping as an alternative method of procurement and to be procured in the local suppliers due to minimal amount be resorted to in the procurement of Office Supplies for the 4th Quarter of 2022, in the amount of *Seventy-One Thousand Nine Hundred Ninety-Nine Pesos and 99/100 only (Php 71,999.99)*; be APPROVED.
