## A BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD OF PROCUREMENT- NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) ON THE PROCUREMENT OF SECURITY SERVICES FOR THE DIVISION OFFICE FOR JANUARY TO JUNE 2023

WHEREAS, the Department of Education, Division of Ozamiz City is mandated to implement programs and projects relative to the realization of DepEd Vision and Mission as stipulated in RA 9155;

WHEREAS, the Department of Education, Division of Ozamiz City Bids and Awards Committee (BAC) recognized the need to procure the Security Services for the Division Office for January to June 2023.

WHEREAS, the amount of the items to be procured does NOT exceed the threshold of what is provided for in Annex H of IRR of RA 9184, as it is only One Hundred Twenty-One Thousand Three Hundred Sixty-Two Pesos and 50/100 only {Php 121,362.50);

WHEREAS, on motion of the BAC Member Eulalio S. Rupinta and duly seconded by BAC Member Fernando D. Sumondong, that alternative method of procurement such as Negotiated Procurement (Small Value Procurement) be resorted to in the procurement of Security Services for the Division Office for January to June 2023.

NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the BAC resolution recommending the use of Negotiated Procurement (Small Value Procurement) as an alternative method of procurement for the procurement of Security Services for the Division Office for January to June 2023, amounting to One Hundred Twenty-One Thousand Three Hundred Sixty-Two Pesos and 50/100 only (Php 121,362.50); be APPROVED.
