**A BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD OF PROCUREMENT- SMALL VALUE  
PROCUREMENT FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF TRAINING  
ON CAPABILITY-BUILDING FOR SCHOOL HEADS ON THE RECOGNITION OF PROFESSIONAL  
DEVELOPMENT PROGRAMS FOR TEACHERS ON DECEMBER 5-6, 2022**

**WHEREAS**, the Department of Education, Division of Ozamiz City is mandated to implement programs and projects relative to the realization of DepEd Vision and Mission as stipulated in RA 9155;

**WHEREAS**, the Department of Education, Division of Ozamiz City Bids and Awards Committee (BAC) recognized the need to procure Catering Services for the Conduct of Training on Capability-Building for School Heads on the Recognition of Professional Development Programs for Teachers on December 5-6, 2022;
