A BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD OF PROCUREMENT- SMALL VALUE PROCUREMENT FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF TRAINING ON CAPABILITY-BUILDING FOR SCHOOL HEADS ON THE RECOGNITION OF PROFESSIONAL DEVELOPMENT PROGRAMS FOR TEACHERS ON DECEMBER 5-6, 2022

WHEREAS, the Department of Education, Division of Ozamiz City is mandated to implement programs and projects relative to the realization of DepEd Vision and Mission as stipulated in RA 9155;

WHEREAS, the Department of Education, Division of Ozamiz City Bids and Awards Committee (BAC) recognized the need to procure Catering Services for the Conduct of Training on Capability-Building for School Heads on the Recognition of Professional Development Programs for Teachers on December 5-6, 2022;

WHEREAS, the amount of the items to be procured does NOT exceed the threshold of what is provided for in Annex H of IRR of RA 9184, as it is only Fifty-Six Thousand Seven Hundred Pesos only (Php 56,700.00);

WHEREAS, on motion of the BAC Member Fernando D. Sumondong and duly seconded by BAC Member Regie A. Catedral, that alternative method of procurement such as Small Value Procurement be resorted to in the procurement of Catering Services for the Conduct of Capability-Building for School Heads on the Recognition of Professional Development Programs for Teachers on December 5-6, 2022;

NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the BAC resolution recommending the use of Small Value Procurement as an alternative method of procurement to resorted in the procurement of Catering Services for the Conduct of Capability-Building for School Heads on the Recognition of Professional Development Programs for Teachers on December 5-6, 2022, in the amount of Fifty-Six Thousand Seven Hundred Pesos only (Php 56,700.00); be APPROVED.
