

## A BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD OF PROCUREMENT- SMALL VALUE PROCUREMENT FOR THE PROCUREMENT OF TIRE 265/80 R18 (MITSUBISHI PICK UP)

WHEREAS, the Department of Education, Division of Ozamiz City is mandated to implement programs and projects relative to the realization of DepEd Vision and Mission as stipulated in RA 9155;

WHEREAS, the Department of Education, Division of Ozamiz City Bids and Awards Committee (BAC) recognized the need to procure Tire 265/80 (Mitsubishi Pick up GLS 2.4D) of the Division of Ozamiz City;

WHEREAS, the amount of the items to be procured does NOT exceed the threshold of what is provided for in Annex H of IRR of RA 9184, as it is only Fifty-Two Thousand Pesos only (Php 52,000.00);

WHEREAS, on motion of the BAC Member Regie A. Catedral and duly seconded by BAC Member Menerva D. Barola, that alternative method of procurement such as Small Value Procurement be resorted to in the procurement of Tire 265/80 (Mitsubishi Pick up GLS 2.4D) of the Division of Ozamiz City;

NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the BAC resolution recommending the use of Small Value Procurement as an alternative method of procurement to resorted in the procurement of Tire 265/80 (Mitsubishi Pick up GLS 2.4D) of the Division of Ozamiz City, in the amount of Fifty-Two Thousand Pesos only (Php 52,000.00); be APPROVED.
