THE DEPARTMENT OF EDUCATION DIVISION OF OZAMIZ CITY FOR YEAR 2023**

KNOW ALL MEN BY THESE PRESENTS:

This AGREEMENT is made and entered into by and between:

The **DEPARTMENT OF EDUCATION DIVISION OF OZAMIZ CITY**, a government agency created by virtue of Republic Act 9155 with office address at IBJT Compound, Barangay Carangan, Ozamiz City, Philippines, duly represented by **JEAN GALLENERO VELOSO**, Schools Division Superintendent, hereinafter referred to as the **ENTITY**;

ELIM AGRIBUSINESS VENTURERS, INC., an enterprise, duly organized, registered and existing under and by virtue of the Philippine Laws, with principal address at Mayor Fernando Ave., Aguada, Ozamiz City, Philippines, represented by its Proprietor, CHAIREN T. LIM, herein referred to as the **"SUPPLIER"**.

WITNESSETH:

WHEREAS, the Revised Implementing Rules and Regulations, hereinafter called the IRR, is promulgated pursuant to Section 75 of Republic Act No. (R.A.) 9184 otherwise known as the Government Procurement Reform Act, for the purpose of prescribing the necessary rules and regulations for the modernization, standardization, and regulation of the procurement activities of the Government of the Philippines (GOP);

WHEREAS, the provisions of the IRR are in line with the commitment of the GOP to promote good governance and its effort to adhere to the principle of transparency, accountability, efficiency and economy in its procurement process. It is the policy of the GOP that procurement of infrastructure projects, goods and consulting services shall be competitive and transparent, and therefore shall go through public bidding, except as provided in the IRR;

WHEREAS, the **SUPPLIER** was considered as the Lowest Responsive Bidder;

NOW THEREFORE, for and in consideration of the above premises, the parties hereby agree, covenant and stipulate the following;

TERMS AND CONDITIONS:

1. The **"SUPPLIER"** shall supply **TWO THOUSAND FIVE HUNDRED (2,500) LITERS** of gasoline/diesel to the **ENTITY** for its service vehicles with an average of **TWO HUNDRED (200) LITERS** per month, particularly;
 - i. TOYOTA INNOVA P5U620
 - ii. SUZUKI MULTICAB SJJ596
 - iii. MITSUBISHI STRADA B6R191
 - iv. TOYOTA HI-ACE VAN P5U620
2. The total consideration of this contract for Calendar Year (C.Y.) 2023 is **TWO HUNDRED THOUSAND PESOS ONLY (PHP 200,000.00)**. This shall be paid by the **"ENTITY"** every month depending on its actual consumption, based on the current and actual selling price of these products; inclusive of tax;
3. This Contract will commence on **JANUARY 1, 2023** and will end on **DECEMBER 31, 2023**;
4. This Contract cannot be pre-terminated by either party without just and valid causes;
5. The **"SUPPLIER"** shall not be in default under this contact for any delay in the delivery of gasoline/diesel products for the **"ENTITY"** caused by force majeure or fortuitous event, provided that the **"SUPPLIER"** informs the **"ENTITY"** in writing of such delay within five (5) days after the occurrence of such delay. Upon receipt of such notice of delay, the **"ENTITY"** shall promptly ascertain the facts and extent of such delay. The decision of the **"ENTITY"** shall be binding upon the **"SUPPLIER"**
6. Any dispute, controversy or claim arising out or relating to this Agreement, or the breach, termination or invalidation thereof shall be settled by arbitration in accordance with the PDRCI Arbitration Rules in force at the time of the commencement of the arbitration.






