WITNESSETH:

WHEREAS, this Agreement is vital in order to establish and deliver efficient and reliable services to the personnel and clients of DepEd Division of Ozamiz City to comply with its mandate provided by law;

NOW THEREFORE, for and in consideration of the above premises, the parties hereby agree, covenant and stipulate the following;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. **Hercules Audio System** shall provide/do the following:
 - a. **Install LED Wall and Lights and Sound** to where the activity will be conducted
 - b. **Do the Stage and Hall Decoration set-up and View Backdrop** (Theme will be provided by the activity in-charge)
for the 11th GURO awards on December 9, 2022.
2. The total consideration of this contract is **Fifty-Five Thousand Pesos only (Php 55,000.00)** which shall be paid by the Entity after the said event.
3. This Contract cannot be pre-terminated by either party without just and valid causes;
4. Any dispute, controversy or claim arising out or relating to this Agreement, or the breach, termination or invalidation thereof shall be settled by arbitration in accordance with the PDRCI Arbitration Rules in force at the time of the commencement of the arbitration.
