REITERATING REGIONAL MEMORANDUM NO. 779, S. 2022 RE: INTENSIVE PROGRESS MONITORING OF SENIOR HIGH SCHOOL CURRICULUM

To: Assistant Schools Division Superintendent Chief Education Supervisors (CID and SGOD) Senior High School Heads (Public and Private) All Others Concerned

- 1. In connection with **Regional Memorandum No. 779**, s. 2022 RE: *Intensive Progress Monitoring of Senior High School Curriculum*, public and private Senior High Schools shall:
 - maximize shortened classes for enrichment sessions on Senior High School (SHS)
 Learning Competencies based on the latest Computer-Based Regional Achievement test results (public only);
 - conduct an inventory of the covered learning competencies based on the Most Essential Learning Competencies (MELCs) and include the uncovered learning competencies in the enrichment classes;
 - prepare a readiness plan for the administration of the National Achievement Test for SHS based on the DepEd Advisory dated October 27, 2022, to be submitted on or before January 9, 2023; and
 - d. use test items for the intensive remedial/enrichment classes based on the 21st Century Skills composed of problem-solving, critical thinking, and information literacy.
- The above-mentioned activities are in preparation for the National Achievement Test to be conducted at the end of January 2023.
- The Schools Division Office (SDO) shall closely monitor the school-based implementation of the intensive remedial/enrichment classes through in-person and/or virtual monitoring.

INTENSIVE PROGRESS MONITORING OF SENIOR HIGH SCHOOL CURRICULUM

To: Schools Division Superintendents All Others Concerned

 Regarding Regional Memorandum No. 697, s. 2022 on the Intensive Remedial/Enrichment Classes for Senior High School Least Mastered Competencies, School Division Offices (SDOs) shall

 a. maximize shortened classes for enrichment sessions on Senior High School (SHS) Learning Competencies based on the latest Computer-Based Regional Achievement Test results,

 conduct an inventory of the covered learning competencies based on the Most Essential Learning Competencies (MELCs),

 c. prepare a readiness plan for the administration of the National Achievement Test for SHS based on the DepEd Advisory dated October 27, 2022,

 d. prepare sample test items based on the 21st-Skills Assessment composed of problem-solving, critical thinking, and information literacy, and

e. submit Monitoring and Evaluation (M & E) mechanisms in conducting Intensive Progress Monitoring of the SHS curriculum.


- The SDOs shall closely monitor the school-based implementation of intensive monitoring.
- 3. The Regional Office (RO), through the Curriculum Learning and Management Division (CLMD) and the Information and Communication Technology Unit (ICTU), will conduct weekly progress reports. The links for the monitoring will be communicated in a separate issuance.

INTENSIVE REMEDIAL/ENRICHMENT CLASSES FOR SENIOR HIGH SCHOOL LEAST MASTERED COMPETENCIES

To: Schools Division Superintendents All Others Concerned

- Regarding the results of the 2022 Rx ADOBE Computer-Based Regional Achievement Test, all schools shall ensure the active participation of the senior high school students in the intensive remedial/enrichment classes on the least mastered competencies.
- As provided for in a DepEd Advisory released on October 27, 2022, the Central Office (CO), through the Bureau of Education Assessment (BEA), will administer this school year the National Achievement Test (NAT) for Grade 12, which will be announced in an official communication.
- All schools implementing senior high schools shall maximize the remedial/enhancement schedules to focus on the identified competencies.
- 4. The Division Education Program Supervisors (Division EPSs) shall consolidate the Intensive Remedial/Enrichment Classes schedules and ensure their implementation and monitoring and evaluation.
- Attached are copies of the least mastered competencies per subject and per grade level (Grade 3, 6, 10, and 12) based on the 2022 Rx ADOBE CBRAT results and the DepEd Advisory for reference.

Administration of the National Achievement Test for Grade 12 for SY 2022-2023

Attention: Regional Testing Coordinators and Division Testing Coordinators

- 1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA) and with the assistance of the regional offices (ROs) and schools division offices (SDOs), shall administer the National Achievement Test for Grade 12 (NATG12) for SY 2022 2023. The test administration date will be announced through a DepEd Memorandum.
- 2. Through its forwarder, BEA shall facilitate the delivery of the test materials to the SDOs which shall commence this November.
- 3. The SDOs that already received their Basic Education Exit Assessment/NATG12 test materials in March 2020 per DepEd Order 033, s.2020 (Administration of the Early Language, Literacy, and Numeracy Assessment for School Year 2018 2019, National Achievement Test for Grade 6 and Grade 10 for SY 2018 2019, and Basic Education Exit Assessment for Grade 12 for SY 2019 2020) are advised to inspect the condition of the delivered test materials and communicate to BEA any concerns about the materials. These materials will be used in the upcoming NATG12 administration.
