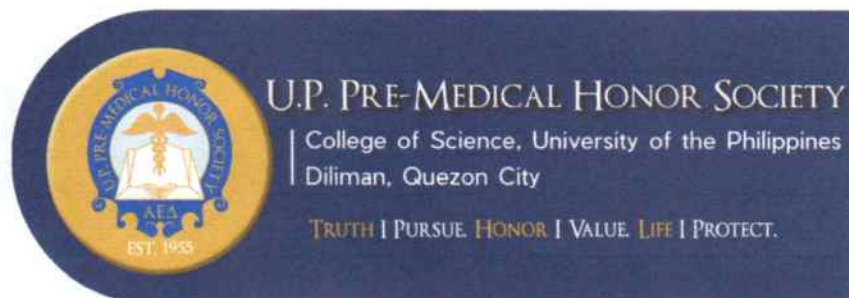

## **PRE-MEDICAL SUMMIT 2023**

**ACTIVITIES:** The pre-medical summit will be divided into two main activities that will transpire across two days of the Summit, panel discussions and workshops. There will also be a keynote speaker at the end of each day to synthesize the event and provide inspiration to the students who aspire to pursue the field of medicine after college.

### **1. Panel Discussions in Pre-Medical Courses**

The organization will invite several speakers, medical students and/or medical professionals, who studied traditional and non-traditional degrees as their pre-medical courses in college. The participants of the event will be given the opportunity to raise questions during an open forum that will be directed to the invited speakers. The invited speakers will highlight their experiences with their degrees, as well as its advantages and disadvantages in order to give aid to the students in choosing the degree that they will be interested in.

Some of the traditional degrees that will be highlighted are:

1. Biology
2. Chemistry
3. Molecular Biology and Biotechnology
4. Psychology
5. Public Health
6. Medical Technology
7. Health Science
8. Nursing
9. Physical Therapy

Some of the non-traditional degrees that will be highlighted are:

### **2. Workshops**

Aside from the panel discussions, there will be organizations that will be invited in order to facilitate workshops with regard to the pre-med courses that they specialize in. This will enable the participants to have a practical experience of what the different pre-med courses are all about. This will be done synchronously and asynchronously so that it will be easier for the participants.

### 3. Keynote Speaker

Keynote speakers will be invited to give an inspirational talk regarding the experiences that they went through as they pursue the field of medicine and their current life as medical professionals. Through this, the students will be able to gain insights on how they want to personalize their journey toward medicine.

## REGISTRATION

### 1. ELIGIBLE ATTENDEES / PARTICIPANTS

The Summit is open to all junior high school (from Grade 9) to all senior high school students across regions in the Philippines. There is no required track (HUMSS, STEM, ARTS, Vocational, etc) for interested senior high school students. The deadline for registration is on **March 25, 2023**.

### 2. SCHOOL INVITATION

The organization will be sending formal invitations to schools all around the Philippines to encourage their students to participate in the Pre-Medical Summit. The invitation is composed of information regarding the event, background of the organization, and the link for the pre-registration form.

### 3. FEES AND INCLUSIONS

Following last year's decision, the organizing committee of the Pre-Medical Summit has decided to waive the registration fee as it seems unnecessary to collect a fee in an online set-up. Furthermore, this year's Summit aims to widen its coverage to other schools from different regions all over the Philippines and not just around Metro Manila.

### 4. ACCEPTANCE

Upon pre-registration, the attendee will be added to a Facebook/messenger group where updates leading to the Summit will be given. Access to the Zoom link will also be provided. Rest assured that no breaching of data will occur.



In line with the thrust of the new administration under the leadership of Vice President Secretary Sara Z. Duterte in ensuring compliance to existing government-mandated laws, and standards, particularly in relation to agency accountabilities, all officials and staff concerned are enjoined to enforce, implement, and monitor compliance with the requirements summarized under Section 5.0 of the Memorandum Circular 2022-1 (MC 2022-1) entitled "Guidelines of the Grant of the Performance-Based Bonus (PBB) for Fiscal Year 2022 under Executive Order (EO) No. 80, s. 2012 and EO No. 201, s. 2016".

Relative thereto, this serves as a reminder on the submission of procurement-related requirements and updating of reports to be posted in the Transparency Seal (TS) Page. Noteworthy, that these requirements shall be the basis in determining the eligibility of responsible units and individuals on the grant of PBB per MC 2022-1 issued by the Inter Agency Task Force on the Harmonization of

National Government Monitoring, Information and Reporting Systems. Below is the list of the requirements and its deadline:

Data requested consists of all projects listed in the respective CY 2023 Annual Procurement Plan (APP), including supplemental APPs, of each DepEd Procuring Entity, and the status of procurement of each project (whether on-going, awarded, failed, or cancelled), the estimated budget (ABC), source of funds, and contract amount, among others. Regional Directors are directed to monitor compliance hereto.
