A BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD OF PROCUREMENT- SMALL VALUE PROCUREMENT FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF TRAINING-WORKSHOP ON INSTRUCTIONAL SUPERVISION FOR SCHOOL HEADS
