## A BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD OF PROCUREMENT - NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) FOR THE PROCUREMENT OF SCHOOL SITE TITLING (SURVEY/TRANSFER/REGISTRATION OF SPECIAL PATENT) OF 4 SCHOOL SITE

WHEREAS, the Department of Education, Division of Ozamiz City is mandated to implement programs and projects relative to the realization of DepEd Vision and Mission as stipulated in RA 9155;

WHEREAS, the Department of Education, Division of Ozamiz City Bids and Awards Committee (BAC) recognized the need to procure School Site Titling (Survey/Transfer/Registration of Special Patent) of 4 School Site;

WHEREAS, the amount of the items to be procured does NOT exceed the threshold of what is provided for in Annex H of IRR of RA 9184, as it is only *One Hundred Sixty Thousand Pesos only (Php 160,000.00);* 

WHEREAS, on motion of the BAC Member Fernando D. Sumondong and duly seconded by BAC member Eulalio S. Rupinta, that alternative method of procurement such as Negotiated Procurement (Small Value Procurement) be resorted to in the procurement of School Site Titling (Survey/Transfer/Registration of Special Patent) of 4 School Site;

NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the BAC resolution recommending the use of Negotiated Procurement (Small Value Procurement) as an alternative method of procurement for the procurement of School Site Titling (Survey/Transfer/Registration of Special Patent) of 4 School Site, amounting to *One Hundred Sixty Thousand Pesos only (Php 160,000.00); be APPROVED.*
