**A BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD OF
PROCUREMENT- SMALL VALUE PROCUREMENT FOR THE PROCUREMENT
OF CATERING SERVICES FOR THE CONDUCT OF LIQUIDATION DAY
FROM MARCH 2023 to DECEMBER 2023**

WHEREAS, the Department of Education, Division of Ozamiz City is mandated to implement programs and projects relative to the realization of DepEd Vision and Mission as stipulated in RA 9155;

WHEREAS, the Department of Education, Division of Ozamiz City Bids and Awards Committee (BAC) recognized the need to procure Catering Services for the conduct of Liquidation Day from March 2023 to December 2023;

WHEREAS, the amount of the items to be procured does NOT exceed the threshold of what is provided for in Annex H of IRR of RA 9184, as it is only **One Hundred Seventy-Eight Thousand Two Hundred Pesos only (Php 178,200.00)**;

WHEREAS, on motion of the BAC Member Fernando D. Sumondong and duly seconded by BAC Member Menerva D. Barola, that alternative method of procurement such as Small Value Procurement be resorted to in the procurement of Catering Services for the conduct of Liquidation Day from March 2023 to December 2023;

NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the BAC resolution recommending the use of Small Value Procurement as an alternative method of procurement for the procurement of Catering Services for the conduct of Liquidation Day from March 2023 to December 2023; in the amount of **One Hundred Seventy-Eight Thousand Two Hundred Pesos only (Php 178,200.00)**; **be APPROVED.**
