**A BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD  
OF PROCUREMENT- SHOPPING ON THE PROCUREMENT OF COMMON USED SUPPLIES AND EQUIPMENT**

**WHEREAS**, the Department of Education, Division of Ozamiz City is mandated to implement programs and projects relative to the realization of DepEd Vision and Mission as stipulated in RA 9155;

**WHEREAS**, the Department of Education, Division of Ozamiz City Bids and Awards Committee (BAC) recognized the need to procure common used supplies and equipment.

**WHEREAS**, the needed supplies are NOT available in the Department of Budget and Management – Procurement Service (DBM-PS) per Certificate of Unavailability stamped on the Purchase Requests from the Misamis Occidental Procurement Service Sub-Depot, dated February 02, 2023;


**WHEREAS**, the amount of the items to be procured does NOT exceed the threshold of what is provided for in Annex H of IRR of RA 9184, as it is only *One Hundred Sixty Five Thousand Seventy Six pesos and 35/100 only (Php 165,076.35)*;




