

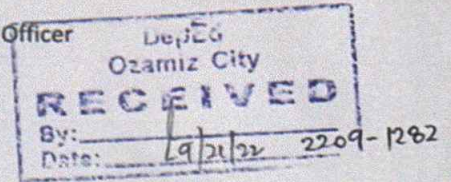

WHEREAS, the City Mayor has approved the conduct of the same subject to the consideration of inputs that the LGU may later on provide;










