**A BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD
OF PROCUREMENT- SHOPPING ON THE PROCUREMENT OF OFFICE SUPPLIES FOR CATADMAN
ELEMENTARY SCHOOL OPERATION**

WHEREAS, the Department of Education, Catadman Elementary School, Division of Ozamiz City is mandated to implement programs and projects relative to the realization of DepEd Vision and Mission as stipulated in RA 9155;

WHEREAS, the Department of Education, Catadman Elementary School -Division of Ozamiz City Bids and Awards Committee (BAC) recognized the need to procure various **office supplies for use in school operation**;

WHEREAS, the office supplies are NOT available in the Department of Budget and Management – Procurement Service (DBM-PS) per Certificate of Unavailability stamped on the Purchase Request dated August 17, 2023;

WHEREAS, the amount of the items to procure exceeds the threshold provided for in Annex H of IRR of RA 9184, in the total amount of *Fifty Thousand Five Hundred Ninety One Pesos & 50/100 only (Php 50,591.50)*;

WHEREAS, the needed office supplies were uploaded in the Philippine Government Electronic Procurement System (PhilGEPS) for the Request for Quotation via online as a requirement for purchase requests amounting to more than Fifty Thousand Pesos;


