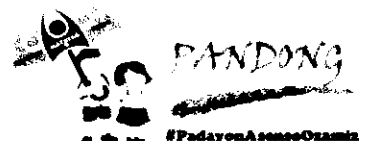

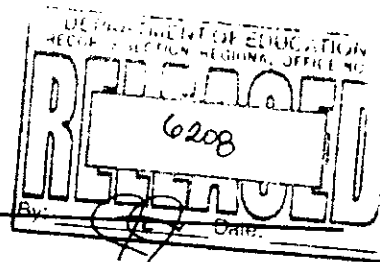

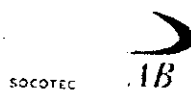

Please be informed further that the following are required for claiming the CORs: a valid PRC ID and a documentary stamp worth 30.00.

If the COR is to be claimed by a representative, the following documents are required:

- a. For an authorized representative who is a PRC license holder:
 - an original and duly signed authorization letter;
 - a copy of the owner's PRC ID; and
 - a copy of the representative's valid PRC license.
- b. For an authorized representative who is NOT a PRC license holder:
 - an original Special Power of Attorney;
 - a copy of the owner's PRC license; and
 - a copy of the representative's government ID.
