CONDUCT OF DIVISION CONSUMER QUIZ BOWL

To: Assistant Schools Division Superintendent Chief Education Supervisors (CID and SGOD) Public and Private Secondary School Heads All Others Concerned This Division

- 1. In reference to the letter sent by LUZ G. GALDA, OIC-Provincial Director, Department of Trade and Industry, dated September 13, 2023, on the conduct of *Provincial Consumer Quiz Bowl-High School Category* in line with the Consumer Welfare Month celebration under Presidential Proclamation No. 1098, s. 1997, with this year's theme, *Gen S: Generation Sustainable*, this Division shall hold a Division Consumer Quiz Bowl on September 26, 2022, Tuesday, 8:30 a.m. to 10:30 a.m., at St. Constance School Mini-Theater, Bangkal, Aguada, Ozamiz City.
- 2. The participants are the Grades 9 or 10 learners coming from public/private schools and their coaches. They shall wear their complete school uniform (with school ID) for easy identification.
- 3. Each Junior High School/Integrated School can have two contestants with only one coach.
- 5. School heads shall register the participants through this link: https://tinvurl.com/DTIQUIZSHOW2023 on or before September 20, 2023.
- 6. This Office shall choose the top 6 highest scoring individuals, and they shall be given a Certificate of Recognition while the non-winners, a Certificate of Participation. The coaches will receive the same.
- 7. Further, the top 6 winners shall represent this Division to the *Provincial Consumer Quiz Bowl* in Oroquieta City, on October 6, 2023, Friday, at 1:30 p.m.
- 8. The participating school shall shoulder the meal and transportation expenses of the participants chargeable against school MOOE subject to the usual accounting and auditing rules and procedures.



PROVINCIAL CONSUMER QUIZ 2023 Guidelines

- 01. The contest is open to all public and private Grade 9 or 10 students.
- 02. Each division is allowed with maximum of six (6) contestants/representatives only.
- 03. Contestants should wear their complete school uniform during the contest for easy identification.
- 04. The contents of the questions are based on the Consumer Act of the Philippines (RA 7394), Price Act (RA 7581), Fair Trade Laws, and other Consumer related laws and policies of the Department of Trade & Industry.
- 05. Contestants are provided with white board, pen and eraser for their use during the contest.
- 06. English is the official language in the conduct of the questions.
- 07. There will be twenty-five (25) questions to be given, ten (10) of which are easy questions, ten (10) questions are average and the other five (5) questions are difficult.
- 08. Points given to every correct answer are as follows:
 - a. One (1) point for easy question
 - b. Two (2) points for average question
 - c. Three (3) points for difficult question
- 09. Each question is to be read twice by the Quiz Master. Countdown starts after the question has been read for the second time.
- 10. Each question is given ten (10) seconds to answer.
- 11. A contestant is allowed to change/erase the answer within the allotted time of the question.
- 12. Wrong spelling wrong.
- 13. The winners will be proclaimed based on cumulative scoring system.
- 14. In case of tie, there will be a set of tie breaking questions for those concerned contestants.
- 15. There will be three (3) judges to score the answers.
- 16. There will be three (3) winners and they will be qualified to join the **Regional** Consumer Quiz Bowl.
- 17. Protest or inquiry should be addressed orally to the chair of the Board of Judges and the decision of the Board is final.
- 18. Prizes will be awarded to the 1st, 2nd and 3rd place winners.

1st Place – Php5,000.00 2nd Place – Php3,000.00 3rd Place – Php2,000.00

19. Deadline for submission of the list of participants is on October 2, 2023.
