- 1. Relative to the attached Memorandum OUOPS 2023-07736 from Atty. Revsee A. Escobedo, Undersecretary for Operations dated August 9, 2023, this Office hereby compose the Division Election Task Force for the 2023 Barangay and Sangguniang Kabataan Elections.
- 2. This Election Task Force shall:
  - a. assist the public school teachers and personnel with their duties before, during and after the elections:
  - help the Commission of Elections (COMELEC) to ensure the free, orderly, honest, peaceful and credible elections;
  - ensure that teachers and personnel are provided with adequate information, technical and legal assistance in the course of the performance of their duties as members of the Electoral Boards; and
  - d. serve as DepEd's institutional link to volunteer organizations and individuals.
- 3. The Division Election Task Force Public Assistance Command Center will be established at the Ground Floor of the Division Office from October 29-31, 2023.
- 4. Enclosure No. 1 contains the Members of the Division Election Task Force.
- 5. ETF Members and other support staff who will render their services shall be granted with Compensatory Time Credit (CTC) subject to the existing CSC and DepEd rules and regulations.
- 6. Further, this Office shall adhere to Equal Opportunity Principle (EOP). Hence, all actions shall be based solely on guidelines set with no discrimination on the account of age, gender, identity, sexual orientation, civil status, disability, religion, ethnicity, or political affiliation.
