**A BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD OF PROCUREMENT- SHOPPING FOR THE PROCUREMENT OF OFFICE SUPPLIES AND EQUIPMENT SUPPORT FUNDS FOR ALS SENIOR HIGH SCHOOL**

WHEREAS, the Department of Education, Division of Ozamiz City Bids and Awards Committee (BAC) recognized the need to procure Office Supplies and Equipment as support funds for ALS Senior High School;




WHEREAS, the amount of the items to be procured does NOT exceed the threshold of what is provided for in Annex H of IRR of RA 9184, as it is only *Two Hundred Fifty Thousand Pesos only (Php 250,000.00)*;






