TRAINING AND CAPACITY BUILDING ON INTEGRATING COMPREHENSIVE SEXUALITY EDUCATION (CSE) IN TEACHING

To: Assistant Schools Division Superintendent Chief Education Supervisors (SGOD and CID) Public Elementary and Secondary School Heads This Division

- 1. This issuance is with reference to DepEd Order No. 31, s. 2028, or the Policy Implementation Guidelines of the Comprehensive Sexuality Education (CSE), which is aimed at establishing a common understanding of the CSE key concepts and messages and ensuring clear implementation of the protocol in the CSE and regarding DM-CI-2020-00237, the National Online Training of Teachers on the Enhanced CE, and DM-OUCI-2020-319 of the conduct of Capacity Building Activities of CSE for PSDS and School Heads.
- 2. In this regard, this Division will conduct Training and Capacity Building for School Heads and Teachers on Integrating Comprehensive Sexuality Education (CSE) in Teaching on January 29-31, 2024, at the BE Palace Hotel, Valconcha Street, Ozamiz City.
- 3. The purposes of this activity are the following:
 - a. Capacitate teachers on how to integrate the key concepts and messages of CSE in the lesson;
 - b. Explore the entry point of the CSE key concepts and messages to the K-12 Curriculum.
 - c. Capacitate the school heads about the LAC CSE modules for proper provision of technical assistance.
- 4. The participants of this activity are the school heads and school CSE focal persons (two participants per school). Each school shall pay a registration fee of Two Thousand Sixty-two pesos (P2,062.00) chargeable against school MOOE subject to the usual accounting and auditing rules and regulations.
