WHEREAS, the Department of Education, Division of Ozamiz City, Hilarion J. Ramiro Jr. Elementary School Bids and Awards Committee (BAC) recognized the need to procure school supplies and materials.


WHEREAS, the needed supplies are NOT available in the Department of Budget and Management – Procurement Service (DBM-PS) per Certificate of Unavailability stamped on the Purchase Requests from the Misamis Occidental Procurement Service Sub-Depot, dated February 02, 2024.

WHEREAS, the amount of the items to be procured does NOT exceed the threshold of what is provided for in Annex H of IRR of RA 9184, as it is Sixty-Two Thousand Seven Hundred Thirty-Six Pesos and Twenty-Seven Centavos (P 62,736.27).

WHEREAS, on motion of the BAC Chairman Marianne U. Puelas and duly seconded by BAC Member Charlyn O. Udal, that alternative method of procurement such as shopping be resorted to in the procurement of school supplies and materials.

NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the BAC resolution recommending the use of shopping as an alternative method of procurement for the procurement of school supplies and materials in the amount of Sixty-Two Thousand Seven Hundred Thirty-Six Pesos and Twenty-Seven Centavos (P 62,736.27), be APPROVED.


