**A BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD  
 OF PROCUREMENT- SHOPPING ON THE PROCUREMENT OF OFFICE SUPPLIES FOR OZAMIZ CITY  
 CENTRAL SCHOOL**

**WHEREAS**, the Department of Education, Ozamiz City Central School, Division of Ozamiz City is mandated to implement programs and projects relative to the realization of DepEd Vision and Mission as stipulated in RA 9155;

**WHEREAS**, the Department of Education, Ozamiz City Central School, Division of Ozamiz City Bids and Awards Committee (BAC) recognized the need to procure supplies from school MOOE;

**WHEREAS**, the needed training supplies are NOT available in the Department of Budget and Management – Procurement Service (DBM-PS) per Certificate of Unavailability dated last February 6, 2024;


**WHEREAS**, the amount of the items to be procured does NOT exceed the threshold of what is provided for in Annex H of IRR of RA 9184, as it is only *One Hundred Sixty-Four Thousand Four Hundred Eighty-Six pesos only (164,486.00)*;

**WHEREAS**, on motion of the BAC Member MARY JOY L. PAUNDOG and duly seconded by BAC Member IMELDA O. CHIU, that alternative method of procurement such as shopping be resorted to in the procurement of supplies for school used;

**NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that the BAC resolution recommending the use of shopping as an alternative method of procurement of office supplies from school MOOE, in the amount of *One Hundred Sixty-Four Thousand Four Hundred Eighty-Six pesos only (164,486.00)*; be APPROVED.






