#### TERMS AND CONDITIONS:

- I.Bidders shall provide correct and accurate information required in this form.
- 2.Any interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
- 3. Quotations submitted must be "sealed".
- 4. Price quotation/s must be valid for a period of forty-five (45) calendar days from the deadline of submission.
- 5.Price quotation/s, to be denominated in Philippine peso, shall include all taxes, duties, and/or levies payable
- 6.Quotations exceeding the Approved Budget for the Contract shall be rejected.
  7.In case of two or more bidders are determined to have submitted the Lowest Calculated Quotation/Lowest Calculated and Responsive Quotation, the Department of Education, Division of Ozamiz City shall adopt and employ "draw lots" as the tie-breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.
- 8. The award of contract shall be made to the lowest calculated quotation and responsive with the technical specifications, requirements and other terms and conditions stated herein. Awarding "by lot" is also considered. 9.The item/s shall be delivered according to the accepted offer of the bidder.
- 10.Item/s delivered shall be inspected on the scheduled date and time of the **Department of Education, Ozamiz City Central School**. The delivery of the item/s shall be acknowledged upon the delivery to confirm the compliance with the technical specifications.
- 1. A warranty security shall be required from the contract-awardee for a minimum period of three (3) months, in the case of Expendable Supplies, or a minimum period of one (1) year, in the case of Non-Expendable Supplies, after acceptance by the Procuring Entity of the delivered supplies. The obligation for the warranty shall be covered by a **special bank** guarantee equivalent to at least one percent (1%) but not to exceed five percent (5%) of the total contract price.

  12.Payment shall be made after delivery and upon the submission of the required supporting documents, i.e., Order Slip
- and/or Billing statement, by the supplier, contractor, or consultant. Our Government Servicing Bank, i.e., the Development Bank of the Philippines, shall credit the amount due to the identified bank account of the supplier, contractor, or consultant not earlier than twenty-four (24) hours, but not later than forty-eight (48) hours, upon receipt of our advice. Please note that the corresponding bank transfer fee, if any, shall be chargeable to the account of the supplier, contractor, or consultant
- 13.Liquidated damages equivalent to one-tenth of one percent (0.1%) of the value of the unperformed portion of the works within the prescribed delivery period shall be imposed per day of delay. The Department of Education, Division of Ozamiz City may terminate the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the mount of the contract, without prejudice to other courses of action and remedies available it.
- 14. The Procuring Entity may cancel or terminate the contract at any time in accordance with the grounds provided under RA No. 9184 and its 2016 revised IRR.
- 15. The RFQ, Purchase Order (PO), and other related documents for the above-stated Procurement projects shall be deemed to form part of the contract.
