KNOW ALL MEN BY THESE PRESENTS:

This AGREEMENT is made and entered into by and between:

The **DEPARTMENT OF EDUCATION DIVISION OF OZAMIZ CITY**, a government agency created by virtue of Republic Act 9155 with office address at IBJT Compound, Barangay Carangan, Ozamiz City, Philippines, duly represented by **NIMFA R. LAGO**, Assistant Schools Division Superintendent, OIC-Office of the Schools Division Superintendent, hereinafter referred to as the **ENTITY**;

VICON-G GRAND CORPORATION, a corporation, duly organized, registered and existing under and by virtue of the Philippine Laws, with principal address, Valconcha St., 50th District, Ozamiz City, Philippines, represented by its Proprietor, **BEACON M. GANADEN**, herein referred to as the **"CONTRACTOR"**.

WITNESSETH:

WHEREAS, the Revised Implementing Rules and Regulations, hereinafter called the IRR, is promulgated pursuant to Section 75 of Republic Act No. (R.A.) 9184 otherwise known as the Government Procurement Reform Act, for the purpose of prescribing the necessary rules and regulations for the modernization, standardization, and regulation of the procurement activities of the Government of the Philippines (GOP);

WHEREAS, the provisions of the IRR are in line with the commitment of the GOP to promote good governance and its effort to adhere to the principle of transparency, accountability, efficiency and economy in its procurement process. It is the policy of the GOP that procurement of infrastructure projects, goods and consulting services shall be

competitive and transparent, and therefore shall go through public bidding, except as provided in the IRR;

WHEREAS, VICON-G GRAND CORPORATION was considered as the Lowest, Calculated and Responsive Bidder;

WHEREAS, this Agreement is vital in order to establish and deliver efficient and reliable services to the personnel and clients of DepEd Division of Ozamiz City to comply with its mandate provided by law;

NOW THEREFORE, for and in consideration of the above premises, the parties hereby agree, covenant and stipulate the following;

TERMS AND CONDITIONS:

- The "CONTRACTOR" will provide venue and serve Lunch (2 main course, rice, pasta/vegie, dessert, bottled juice/drinks); AM and PM Snacks (1 bottled/canned drinks and pasta/bread) "Monthly" good for 110 participants and the menu will be based on the "ENTITY" preferences;
- 2. The "CONTRACTOR" will also provide the following provisions: a) at least 3 microphones and power sound system, b) 1 presidential table (table skirted) that can accommodate 8 DepEd VIP's, c) 3 (skirted tables) food stations, d) with overflowing coffee and water, and e) generator in case of power interruption;
- 3. The consideration of this contract is Thirty-Eight Thousand Three Hundred Ninety Pesos only (Php 38,390.00) per activity for a total of Two Hundred Thirty Thousand Three Hundred Forty Pesos only (Php 230,340.00) for the 1st Semester of CY 2024. Payment will be made based on the actual activity conducted. Billing shall be issued to the office every after activity for processing of payment purposes.
- 4. The activity dates are as follows: JANUARY 25, 2024, FEBRUARY 29, 2024, MARCH 21, 2024, APRIL 25, 2024, MAY 30, 2024 AND JUNE 27, 2024;
- 5. This Contract cannot be terminated by both parties without just and valid causes;

The "CONTRACTOR" shall not be in default under this contract for any delay in the performance of the above mentioned service for the "ENTITY" caused by force majeure or fortuitous event, provided that the "CONTRACTOR" informs the "ENTITY" in writing of such delay within five (5) days after the occurrence of such delay. Upon receipt of such notice of delay, the "ENTITY" shall promptly ascertain the facts and extent of such delay. The decision of the "ENTITY" shall be binding upon the "CONTRACTOR"
- 7. Any dispute, controversy or claim arising out or relating to this Agreement, or the breach, termination or invalidation thereof shall be settled by arbitration in accordance with the PDRCI Arbitration Rules in force at the time of the commencement of the arbitration.
