KNOW ALL MEN BY THESE PRESENTS:

This AGREEMENT is made and entered into by and between:

The **DEPARTMENT OF EDUCATION DIVISION OF OZAMIZ CITY**, a government agency created by virtue of Republic Act 9155 with office address at IBJT Compound, Barangay Carangan, Ozamiz City, Philippines, duly represented by **NIMFA R. LAGO**, Assistant Schools Division Superintendent, OIC-Office of the Schools Division Superintendent, hereinafter referred to as the **ENTITY**;

VICON-G GRAND CORPORATION, a corporation, duly organized, registered and existing under and by virtue of the Philippine Laws, with principal address, Valconcha St., 50th District, Ozamiz City, Philippines, represented by its Proprietor, **BEACON M. GANADEN**, herein referred to as the **"CONTRACTOR"**.

WITNESSETH:

WHEREAS, the Revised Implementing Rules and Regulations, hereinafter called the IRR, is promulgated pursuant to Section 75 of Republic Act No. (R.A.) 9184 otherwise known as the Government Procurement Reform Act, for the purpose of prescribing the necessary rules and regulations for the modernization, standardization, and regulation of the procurement activities of the Government of the Philippines (GOP);

WHEREAS, the provisions of the IRR are in line with the commitment of the GOP to promote good governance and its effort to adhere to the principle of transparency, accountability, efficiency and economy in its procurement process. It is the policy of the GOP

that procurement of infrastructure projects, goods and consulting services shall be competitive and transparent, and therefore shall go through public bidding, except as provided in the IRR;

WHEREAS, VICON-G GRAND CORPORATION was considered as the Lowest, Calculated and Responsive Bidder;

WHEREAS, this Agreement is vital in order to establish and deliver efficient and reliable services to the personnel and clients of DepEd Division of Ozamiz City to comply with its mandate provided by law;

NOW THEREFORE, for and in consideration of the above premises, the parties hereby agree, covenant and stipulate the following;

TERMS AND CONDITIONS:

- The "CONTRACTOR" will provide venue (Be Palace Hotel) and serve Lunch (Rice, Drinks, 2 viands, 1 pasta/vegie, Mixed Fruits, Soup); AM Snacks (Kakanin/Pinoy Snacks and Drinks) and PM Snacks (Kakanin/Pinoy Snacks and Hot Choco) good for 86 participants for 3 Days and the menu will be based on the "ENTITY" preferences during the conduct of workshop on the refinement of the NLC lesson exemplars;
- The "CONTRACTOR" will also provide the following provisions: a) Free use of Microphone, Sound System, WIFI, projector, b) Hot/Cold Water, and c) with overflowing coffee;
- The total consideration of this contract is Ninety Thousand Forty-Two Pesos only (Php 90,042.00). Payment will be made after the said activity.
- 4. The activity dates are as follows: March 13-15, 2024;
- 5. This Contract cannot be terminated by both parties without just and valid causes;
- The "CONTRACTOR" shall not be in default under this contract for any delay in the performance of the above mentioned service for the "ENTITY" caused by force majeure or fortuitous event, provided that the "CONTRACTOR" informs the "ENTITY" in writing
