Greetings from the Philippine Statistics Authority!

In connection with the national implementation of the 2024 Functional Literacy, Education and Mass Media Survey (FLEMMS), we are writing to respectfully request your permission to allow selected students, identified as sample respondents, to be interviewed by our Statistical Researchers and answer the FLEMMS Questionnaire while in school.

The 2024 FLEMMS is designed to provide a quantitative framework and a reliable baseline to inform the formulation and monitoring of a wide range of policies and programs related to education and literacy and as an advocacy tool for national policies and development plans.

Specifically, it aims to:

- 1. estimate the proportion of the population 5 years old and over who are basically literate;
- 2. estimate the proportion of the population 10 to 64 years old who are functionally literate and to determine their socio-economic characteristics;
- determine the educational skill qualifications of the population in terms of formal schooling; and,
- 4. determine the mass media exposure of the population.

In line with this, we have identified instances where children, particularly those residing in remote areas and/or those who spend a significant amount of time in school during the duration of the survey period, may not have the opportunity to answer the survey in their respective households.

By allowing the students to respond to the survey during school hours, we can ensure greater participation and enhance the reliability of the collected data for this survey. We are willing to coordinate with school staff and other officials to minimize any disruption to regular school activities.

We believe that this approach will significantly improve the survey's reach and provide a more accurate representation of the data that will be collected for this undertaking.
