- 1. With reference to Regional Memorandum 0759 s. 2024, re: Observance of the National Indigenous Peoples (IP) Month 2024 and pursuant to Presidential Proclamation No. 1906, s. 2009, titled "Declaring the Month of October of Every Year as the National Indigenous Peoples Month," the Schools Division of Ozamiz City joins the nation in celebrating this year's IP Month with the theme: "Katutubong Filipino: Pagtibayin ang Tagumpay 2030 (Indigenous Filipinos: Strengthening the Success by 2030).
- 2. Indigenous Peoples Education (IPEd) implementing schools may celebrate the National IP Month 2024 with utmost consideration of DepEd Order No. 9, s. 2005 on instituting measures to increase engaged time-on-task through any of the following activities:
 - a. School-based culmination activity highlighting the learning gains of IPEd Program;
 - b. School activities where Indigenous Peoples can perform their cultural expressions/presentations;
 - c. Hanging of streamers/tarpaulins with the theme for this year's celebration; and
 - d. Dialogue or "Kamustahan" with IP elders, community representatives, and Consultative Advisory Body (CAB) members.
- 3. Division Office personnel, school heads, and teachers in the field are encouraged to wear "IP-inspired attire" during Fridays for the month of October.
- 4. As a documentation, IPEd implementing schools are required to submit a 7-minute video presentation of the IP Month Celebration as this is also required to be

submitted in the Regional Office. The videos should be submitted in mp4 format on or before November 11, 2024. The submission link will be forwarded to the official chat group of IPEd implementing schools.

- 5. During the conduct of the above-mentioned activities, schools are directed to adhere to IP community protocols and observe DepEd Order 51, s. 2014, or the Guidelines on the Conduct of Activities and Use of Materials Involving Aspects of Indigenous Peoples Culture. This will ensure that the activities are implemented in a respectful and ethical manner.
- 6. Expenses relative to the conduct of these activities shall be charged against the Division IPEd Program Support Fund (PSF) for division-led activities while the expenses at the school level shall be charged to School MOOE subject to the usual accounting and auditing procedures.

- 1. This Office supports DepEd Memorandum DM-CT-2024 titled Observance of the National Indigenous Peoples Month 2024 of Regions and Divisions Implementing the Indigenous Peoples Education (IPED) Program and Presidential Proclamation No. 1906, s. 2009 titled Declaring the Month of October of Every Year as National Indigenous Peoples.


