**RESUMPTION OF SCHOOL-BASED IMMUNIZATION (SBI) PROGRAM  
AFTER COVID-19 PANDEMIC INTERIM GUIDELINES**

To: Assistant Schools Division Superintendent  
Chief Education Supervisors (SGOD and CID)  
Elementary/Secondary School Heads/Department Heads

This Division

1. With reference to Regional Memorandum No. 0648, S. 2024 dated September 9, 2024, titled “Resumption of School-based Immunization (SBI) Program after COVID-19 Pandemic Interim Guidelines”, this Office in partnership with the City Health Office, will conduct School-based Immunization in all schools in the Division.
2. Targets for School-based Immunization are all learners from **Grade 1 and Grade 7 as recipients of Measles-Rubella (MR) and Tetanus-Toxoid (TD) vaccines, and Grade 4 female learners for the 1<sup>st</sup> dose of Human Papillomavirus (HPV) vaccine.**
3. School Heads will act as SBI In-Charge for their respective schools.
4. A School Readiness Assessment Form is required from each participating school to evaluate which areas are met or require improvements.
5. Schools will prepare the master lists of learners using Recording Form 1 for Grade 1, Form 2 for Grade 7 and Form 3 for Grade 4 female learners.
6. Schedule of vaccination will be prepared in coordination with the City Health Office of Ozamiz City.
7. A vaccination site will be set-up in schools guided by a Vaccination Site Floor plan from the SGOD - School Health Section.
8. After vaccination, learners will be observed for **2 hours** on their respective classrooms for any Adverse Effects Following Immunization (AEFI) and be allowed to go home should there be no complaints thereafter.

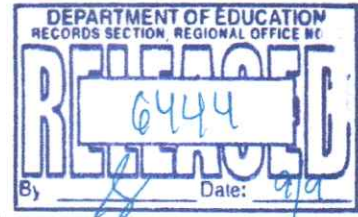

RESUMPTION OF SCHOOL-BASED IMMUNIZATION (SBI) PROGRAM  
AFTER COVID-19 PANDEMIC INTERIM GUIDELINES

To: Assistant Regional Director  
Schools Division Superintendents  
All Others Concerned

1. Immunization protects against vaccine-preventable diseases like measles, rubella, tetanus, diphtheria, and HPV. The School Based Immunization (SBI) Program was established in 2013 and held annually in public schools until the COVID-19 pandemic. In 2020, due to mobility restrictions and the suspension of in-person classes, the SBI transitioned from a school-based to a community-based approach.
2. Regional Directors, Schools Division Superintendents, and other school officials are encouraged to fully support vaccination activities. School health personnel are expected to coordinate closely with regional, provincial, and city health officers during these vaccination efforts.
3. It is essential to implement the School Based Immunization (SBI) Program. The full resumption of face-to-face classes increases the risk of school learners contracting vaccine-preventable diseases (VPDs). The SBI Program should revert to a school-based setting considering the return to in-person classes.
4. Guidelines on the Resumption of School-Based Immunization after the COVID-19 Pandemic are contained in the attachment.
5. Parental consent or assent below 18 y/o must be secured prior to the activity.
