- Evaluate documents of the applicants for JDVP partnership whether they are compliant to DepEd standard requirements such as sufficient tools and equipment, ventilation and safety of learners, absorptive capacity of 1:25 per 100 sq. meters workshop/laboratory and teachers/trainers' qualification which must be at least TM I/NTTC;
 - Conduct monitoring and post evaluation in the conduct of the JDVP implementation; and
 - Assist and provide technical assistance in the implementation of JDVP.
