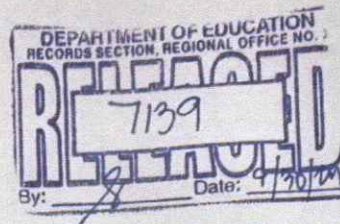

**REGIONAL SCHOOL MENTAL HEALTH FORUM AND ORIENTATION
 ON MENTAL HEALTH CRISIS MANAGEMENT**

1. The Department of Education (DepEd) Region X, through the ESSD-Health and Nutrition Section, with the support of the Bureau of Learner Support Services - School Health Division (BLSS-SHD), will conduct the **Regional School Mental Health Forum and Orientation on Mental Health Crisis Management at Chali Resort and Conference Center, Cagayan de Oro City, on November 12-15** as part of this year's Mental Health Awareness Month Celebration.

2. The activity aims to capacitate DepEd health and school personnel in responding to learners experiencing mental health crisis through awareness of prevention, intervention, postvention, reporting, and caring for carers in the school setting.

b. One	Focal of SMHP (Nurse II)
c. One	Registered Guidance Counselor
d. One	Learners Rights and Protection Officer
e. One	School Head/Principal

4. Accommodation and meals during the training shall be charged to the Regional Office (RO) PSF for School Mental Health while all other travel and incidental expenses shall be charged to local funds, subject to the usual accounting and auditing rules and regulations. The identified participants shall be entitled to a Compensatory Time-Off (CTO), as applicable, in accordance with the Civil Service Commission's (CSC) rules and regulations.




