1. In preparation for the upcoming 2024 One Asenso Misamis Occidental Palaro/Provincial Athletic Meet, scheduled to take place from December 11 to 14, 2024, in Oroquieta City, this Office is pleased to announce the list of Technical Officials for the event.
 2. Technical Officials who will serve during the provincial athletic meet are required to file Authority to Travel. They are also enjoined to coordinate with the Tournament Directors regarding the schedules of solidarity meetings and games. Sports uniforms and bedding will be provided by the host Division.
 3. School Heads must ensure that classes left behind by teachers serving as Technical Officials are attended to, and measures are taken to address possible learning gaps while they are away from school, in compliance with DepEd Order No. 9, s. 2005 (Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith).
 4. Teachers who will serve as Technical Officials during weekend sports training/competitions and other related activities shall be granted **service credits**. In contrast, non-teaching personnel who serve as Technical Officials shall also be granted **Compensatory Time-Off (CTO)**, DepEd Order No. 84, s. 2003, re: Addendum to DepEd Order No. 53, s. 2003, (Updated Guidelines on Grant of Service Credits to Teachers); and Civil Service Commission and Department of Budget and Management Joint Circular No. 2, s. 2004.
 5. Transportation, meals, and other incidental expenses shall be charged against school MOOE/local funds subject to the usual accounting and auditing rules and regulations.




