1. Per Divisional Memorandum No. 67, CONDUCT OF INTENSIVE IN-HOUSE TRAINING FOR ONE ASENSO MISAMIS OCCIDENTAL PROVINCIAL ATHLETIC ASSOCIATION – OZCAA DELEGATES, this Office announces the medical responders for the intensive sports in-house training in preparation for the 2025 Northern Mindanao Regional Athletic Association (NMRAA) Meet.
2. Medical responders shall perform the following:
  - a) Attend to the medical concerns of the participants during the intensive in-house training;
  - b) Initiate and coordinate emergency response procedures in the event of serious injuries or medical emergencies to the provincial medical responders.
  - c) Offer reassurance and support to delegates during medical incidents, helping to manage stress and anxiety.
3. The following School Health Section personnel shall serve as Medical Responders within the training window (March 1-31, 2025) in Tangub City and Oroquieta City, and shall report to the Division Office to perform their routine duties during the days wherein they are not on-duty as medics.


