This AGREEMENT is made and entered into by and between:

It is the policy of the GOP that procurement of infrastructure projects, goods and consulting services shall be competitive and transparent, and therefore shall go through public bidding, except as provided in the IRR;

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

  - b. **Drinks during snacks : Juice in Can and Drinks during lunch: Softdrinks In Can/Bottle**
2. **"The Contractor"** shall provide the following: sound system with atleast 3 microphones, projector screen, with flowing coffee and free WiFi.
3. The total consideration of this contract is **One Hundred Twenty Two Thousand Three Hundred Twenty Five Pesos only (Php 122,325.00)** which shall be paid by the Entity after the said activity.
4. This Contract cannot be pre-terminated by either party without just and valid causes;
5. Any dispute, controversy or claim arising out or relating to this Agreement, or the breach, termination or invalidation thereof shall be settled by arbitration in accordance with the PDRCI Arbitration Rules in force at the time of the commencement of the arbitration.


