This AGREEMENT is made and entered into by and between:

LAGO**, Officer-in-Charge, Schools Division Superintendent, hereinafter referred to as the **ENTITY**;

WITNESSETH:

WHEREAS, the Revised Implementing Rules and Regulations, hereinafter called the IRR, is promulgated pursuant to Section 75 of Republic Act No. (R.A.) 9184 otherwise known as the Government Procurement Reform Act, for the purpose of prescribing the necessary rules and regulations for the modernization, standardization, and regulation of the procurement activities of the Government of the Philippines (GOP);

WHEREAS, the provisions of the IRR are in line with the commitment of the GOP to promote good governance and its effort to adhere to the principle of transparency, accountability, efficiency and economy in its procurement process. It is the policy of the GOP that procurement of infrastructure projects, goods and consulting services shall be competitive and transparent, and therefore shall go through public bidding, except as provided in the IRR;

WHEREAS, this Agreement is vital in order to establish and deliver efficient and reliable services to the personnel and clients of DepEd Division of Ozamiz City to comply with its mandate provided by law;

NOW THEREFORE, for and in consideration of the above premises, the parties hereby agree, covenant and stipulate the following;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- "The Contractor" shall render catering services and provide training venue (free of charge), electric power (free of charge) for the Conduct of 5th Management Committee Meeting on October 29, 2024 (9:00 A.M. 6:00 P.M.) based on specifications provided below:

 - Drinks during snacks : Juice in Can and Drinks during lunch: Softdrinks In Can/Bottle
- 2. "The Contractor" shall provide the following: sound system with atleast 3 microphones, projector screen, with flowing coffee and free WiFi.
- 3. The total consideration of this contract is **One Hundred Twenty Two Thousand Three Hundred Twenty Five Pesos only (Php 122,325.00)** which shall be paid by the Entity after the said activity.
- 4. This Contract cannot be pre-terminated by either party without just and valid causes;
- 5. Any dispute, controversy or claim arising out or relating to this Agreement, or the breach, termination or invalidation thereof shall be settled by arbitration in accordance with the PDRCI Arbitration Rules in force at the time of the commencement of the arbitration.
