With reference to DepEd Order No. 62 s. 2011 re: Adopting the National Indigenous Peoples (IP) Education Policy Framework and in support to the implementation of Indigenous Peoples Education (IPED) program, this Division shall conduct a “Workshop on the Review and Enhancement of IPED Framework and Cultural Standards” on March 10-11, 2025 at Be Palace Hotel, Ozamiz City.

2. The activity aims to:

- a. collaboratively review and analyze the existing IPED Framework and Cultural Standards, identifying strengths, weaknesses, gaps, and areas for improvement based on the experiences and perspectives of Indigenous Peoples' elders, implementers, and other stakeholders;
- b. develop concrete recommendations for the enhancement of the IPED Framework and Cultural Standards, including specific revisions, additions, and strategies for implementation that address identified gaps and emerging challenges; and
- c. strengthen partnerships and collaboration among Indigenous Peoples' communities, fostering a shared understanding of the framework and cultural standards, and building consensus on strategies for their effective implementation and monitoring.
