Teaching and teaching-related personnel shall be granted vacation service credits and compensatory time-off, respectively, based on DepEd Order No. 53, s. 2003, re: Updated Guidelines on the Grant of Vacation Service Credits to Teachers; and CSC and DBM Joint Circular No. 2, s. 2004, re: Non-Monetary Remuneration for Overtime Services Rendered subject to the approval of the Schools Division Superintendent
6. Other matters mentioned in Divisional Memorandum No. 017, s. 2025, shall remain in effect.
