**WITNESSETH:**

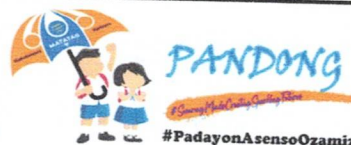



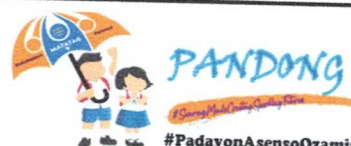
