NOW THEREFORE, for and in consideration of the above premises, the parties hereby agree, covenant and stipulate the following;

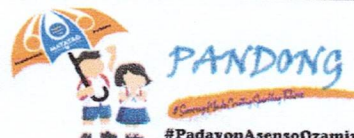




