**CONDUCT OF DENTAL SERVICES AT THE SCHOOL DENTAL HEALTH CARE PROGRAM CLINICS DURING THE SCHOOL SUMMER BREAK**

To: Assistant Schools Division Superintendent

This Division

1. To promote and maintain optimum health of learners and personnel, the Dental Services Unit of this Division will be at the School Dental Health Care Program (SDHCP) clinics during the school break from April 22 to June 4, 2025.
2. The division dentists will conduct the following dental services for learners and personnel:
  - a. oral health examination and consultations;
  - b. simple tooth extractions and Oral Urgent Treatments; and
  - c. referrals for those needing further management.
3. With consideration for infection prevention and control, a maximum number of fifteen (15) patients per day will be accommodated at the SDHCP clinics. *Potential patients are required to contact the Division Dentists directly and in advance for the initial teleconsultation/interview and appointment.*
4. Patients below 18 years old must be accompanied by a parent or guardian who is directly involved in his/her care.
5. Dental anesthetic solution and medicines shall be provided by the SDHCP program until supplies last, after which shall be shouldered by the patients or parents.
6. The participation of the learners and school personnel in this activity is in adherence to the principles of equal opportunity for continuous improvement that there is no discrimination on account of age, gender, civil status, disability, religion, political affiliation, medical conditions among others.
