- 1. With reference to DepEd Order No. 62 s. 2011 re: Adopting the National Indigenous Peoples (IP) Education Policy Framework, this Division shall conduct "Upskilling of School Heads, Supervisors and other DepEd Personnel on Indigenous Peoples Education Program Supervision" on May 19-20, 2025 at Alona's Summer Breeze Resort Hotel, Panaon, Misamis Occidental.
- 2. The training aims to:
 - a. equip the school heads and supervisors on the knowledge and skills in supervising the implementation of IPEd;
 - b. revisit the contextualization process and interfacing of DepEd and IP competencies to equip the school heads and supervisors on the philosophies and principles of Indigenous Peoples Education; and
 - c. conduct quality assurance of the indigenized lesson plans crafted by the teachers that are aligned with the Revised K to 12 Curriculum.
- 3. The participants to this training are the 27 school heads from the IPEd implementing schools, Education Program Supervisors, Public Schools District Supervisors, three support staff composed of CID Office Secretary, Division Librarian and Information Technology Officer, Division Budget Officer, Division Accountant, Administrative Officer V for Admin Services, SEPS-M&E, CID Chief Education Supervisor, Assistant Schools Division Superintendent and the Schools Division Superintendent.
- 4. In the event that the school head has an equally important commitment on the scheduled date, a designated teacher-participant shall represent the
