**FINAL TESTING AND SEALING (FTS) OF THE AUTOMATED
COUNTING MACHINE**

Smith, the City Election Officer, this Office announces the conduct of **Final Testing and Sealing (FTS) of the Automated Counting Machine (ACM) on May 7, 2025**. In view thereof, the Electoral Boards are required to be at the City Gymnasium, Lam-an Ozamiz City before 8:00 o'clock in the morning for the release of the ACMs which will then be transported and delivered from City Gymnasium to the designated polling places where the FTS be conducted.
