1. This issuance refers to the upcoming 2025 National Schools Press Conference (NSPC) in Ilocos Sur, Region 1 on May 19-23, 2025.
2. The Ozamiz City Division delegates for the 2025 NSPC, composed of NSPC qualifiers and coaches/school paper advisers, outstanding Campus Journalist and adviser, divisional journalism coordinators, CID Chief ES, Assistant Schools Division Superintendent, and Schools Division Superintendent, are outlined in the attachment.
3. All the participants are advised to take them with a copy of the latest issue of their school publications in Portable Document Format (PDF) or digital format, secure parental consent, and medical certificate to qualify for the contest.
4. Non-contestants, parents, and other school officials and personnel who wish to attend the activity but are not part of the official regional delegation are required to seek their own accommodation.
5. Only the official regional delegates are allowed in the billeting quarter. No participant is allowed to sleep outside the billeting school without the permission and approval of the delegation head.
6. Prior to the departure to NSPC and NFoT, all NSPC/NFoT-bound participants shall participate in the Division Pre-Departure Orientation Seminar (PDOS) at the Division Conference Hall on May 15, 2025, at 1:00 p.m. and are expected to strictly attend enhancement training set by the Regional Office on May 7-9, 2025 in Lanao del Norte. *Please refer to Regional Memorandum No. 287, s. 2025 for the details and provisions, particularly on the enhancement training.*
7. Further, the official delegates are advised to take with them 2x2 picture for the ID card. They shall also be provided with uniform to be shouldered by the Regional Office.




