2. The *Department of Education, Division of Ozamiz City* now invites bids for the above Procurement Project. Delivery of the Goods is based on the **actual dates of the Feeding Days**. Bidders should have completed, within **3 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *Bids and Awards Committee (BAC) Secretariat, Department of Education, Division of Ozamiz City* and inspect the Bidding Documents at the address given below during **8:00 a.m. – 12:00 noon and 1:00 – 5:00 p.m., Monday to Friday**.

5. A complete set of Bidding Documents may be acquired by interested Bidders on **May 27, 2025** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 10,000.00** for Lot 1 and **Php 5,000.00 each** for Lot 2,3 and 4.* The Procuring Entity shall allow the bidder to present its proof of payment for the fees ***either presented in person, by facsimile, or through electronic means.***
6. The ***Department of Education, Division of Ozamiz City*** will hold a Pre-Bid Conference on **May 28, 2025; 9:00 am at Division Office Boardroom 2<sup>nd</sup> Floor, Division of Ozamiz City, IBJT Compound, Carangan, Ozamiz City** through ***Face to Face*** or via ***Online through this link <https://meet.google.com/xso-ygyc-yev>***, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through (i) **manual submission at the office address indicated below**, on or before **June 9, 2025; 1:45 PM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **June 9, 2025; 2:00 P.M. via Face-to-Face** at the ***Division Office Boardroom 2<sup>nd</sup> Floor, Division of Ozamiz City, IBJT Compound, Carangan, Ozamiz City***. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity. Bids must be in **Five sets of hard copies** (one original and four photocopies). Late Bids shall **NOT** be accepted
10. The ***Department of Education, Division of Ozamiz City*** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
