1. In reference to Divisional Memorandum No. 237 s. 2025, “CONDUCT OF DIVISION SPORTS ACTIVITIES FOR SY 2025-2026”, this Office announces the postponement of the Ozamiz City Athletic Association Meet 2025 from August 27-29, 2025 to September 3-6, 2025.
2. To comply with DepEd Order (DO) No. 9, s. 2025 “ Instituting Measures to Increase Engage Time on Task and Ensuring Compliance Therewith: the following guidelines shall be adopted. a. After – class try outs and Inter-Sports Clubs tune up games, Intramurals and other selection modalities shall be employed for the selection of quality athletes. b. Practices shall be done during PE/Sports hours as reflected in the class programs, after class hours and during weekends.
3. Cut-off Year for Athletes’ Eligibility:
 - a. Elementary athletes - born on or after January 1, 2013
 - b. Secondary athletes - born on or after January 1, 2008.
4. A separate issuance shall be posted for the playing venues, technical working committees, tournament directors, and tournament officiating officials.
5. Teaching personnel who will serve during weekend sports training/competitions and other related activities shall be granted service credits. In contrast, non-teaching personnel who serve as event monitors, medical teams, coaches, trainers, and sports officials shall also be granted Compensatory Time-Off (CTO), DepEd Order No. 84, s. 2003, re: Addendum to DepEd Order No. 53, s. 2003, (Updated Guidelines on Grant of Service
